Selection of an Individual Consultant as the lead technical consultant for the Court's Electronic Case Management System (ECMS) and Open Text ECM

- The Community Court of Justice ECOWAS has embarked on the digitization of its judicial and administrative processes with the recent deployment of two key platforms. First, the Electronic Case Management System (ECMS), a digital platform that allows the electronic filing and management of cases and, second, the Open Text Enterprise Content Management (ECM); dedicated to the automation of administrative and Human Resources processes. The Court, in this regard, is engaging the Service Contract for the Selection of an Individual Consultant to function as the technical consultant for the Court's ECMS and the OpenText ECM platforms for both the Court and the ECOWAS Commission.
- 2. The overall objective of this consultancy is to recruit a digital transformation expert to Coordinate the activities related to the upcoming launching of ECMS, lead the training of lawyers in the ECOWAS Member States, and lead the team in charge of the post-go-live incident management. The Consultant will also coordinate the activities related to the upcoming launching of OpenText ECM of the ECOWAS Court and the re-launching of OpenText ECM at the Commission. He or she shall lead the training of end-users, and work with the team in charge of the post-go-live incident management.
- The consulting services ("the Services") include the deliverables listed under paragraph 4 below and the duration of the contract shall be for a period of one (1) year from the date of the signing of the contract.

Duties and responsibilities of the Consultants

- 4. The Consultant in Digital Transformation should:
 - Work in hybrid mode: On site and remotely based on identified needs.
 - Be continuously available to Court for ECMS and to both the Court and the Commission for the OpenText ECM platforms.
 - Coordinate and ensure the development of user manuals, training manuals and system documentation, based on final platform deployments and implementations for both the Court and the Commission.
 - Coordinate the training & capacity building of ECMS and OpenText ECM super IT administrators, super users, and end-users.





 Coordinate the management of emerging incidents and challenges for ECMS and OpenText ECM platforms after their respective launchings.

- (2) Quarterly progress reports for the ECOWAS Court and Commission
- 5. The Community Court of Justice, ECOWAS now invites Individual Consultants ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are as follows:

Educational Qualification

Advanced university degree (minimum master's degree) in Computer Science, Information Technology, and Software Engineering, or related field.

Experience

- At least 10 years of experience in digital transformation in regional or international judicial institutions.
- Must have experience with project management methods (including PRINCE2, SCRUM or PMP)
- Experience with the installation, design, and deployment of OpenText ECM.
- Certification in IT Service Management (ITIL).
- Knowledge of and experience with various SAP modules and with the integration of OpenText ECM and SAP is preferred.

Language

The Individual Consultant shall be fluent (reading, writing, speaking) in English and French languages. The Practical knowledge (reading, writing, speaking) of the Portuguese language would be an advantage.

NB: The attention of interested Individual Consultants is particularly drawn to Article 118 of the ECOWAS Revised Procurement Code ("Infringements by Candidates, Bidders and Awardees"), providing information on corrupt or fraudulent practices in competing for or executing a contract.
